



## **INSTRUCTIONS FOR DECAL CONTROL SHEET**

Thank you for requesting a Santa Rosa Plateau decal. The use of the decal for identification of resident vehicles should provide better control of access to the Plateau and increased safety.

Please fill out a separate DECAL CONTROL SHEET for each of your vehicles

Lines 1 and 2 are self explanatory.

Line 3: Assessors Parcel Number: Please fill in the number as shown on your Riverside County Property Tax bill, or you may write in the APN shown on the annual LCPOA property assessment statement from The Walters Management Company.

Line 4: Vehicle Information: Please fill in the data for your vehicle

Lines 5 thru 8: Check the box that fits your situation. There are some areas on the Plateau that are not within association boundaries. These are called "unassociated".

Lines 6 thru 10: Evidence of resident, rental, or non-resident property ownership status can be demonstrated by providing a copy of one of the following:

- A bill from the Southern California Gas Company
- A statement from the Rancho California Water Company
- A statement from CR&R for trash pick up service.
- A copy of a tax statement from the County Assessors Office.
- A piece of paper that shows name and address in La Cresta. The important thing is something to show the applicant's name and address.

Be sure to attach a copy of one of the above to the Decal Control Sheet.
